1. Payments due from mare owner:

- a) The service fee for **2012** shall be \$_____ A non-refundable booking fee of \$250.00 (included in service fee) is required upon the return of this contract. For shipped semen, the first collection is included in service fee. **However, the overnight shipping cost is the responsibility of the mare owner. (U.S. \$150.00 / Canada \$175.00)**
****Shipping rates are subject to change if Fed Ex/UPS rates change****
- b) Mare care (for mares bred at Twin Creek Farms). PLEASE REQUEST TWIN CREEK FARMS RATE SHEET.
- c) For shipped semen, should additional collections be required, the mare owner agrees to pay \$200.00 per additional collection as well as actual shipping costs as stated above. Please see "Transported Semen Information Sheet" for additional information.
- d) **ALL FEES/CHARGES must be paid before mare leaves premises or before semen is shipped. It is best to provide Twin Creek Farms with credit card information for any last minute requests or charges.**

2. Health and Condition of Mare (onsite):

- a) Mare owner agrees that mare shall be healthy and in sound breeding condition and the stallion owner **may** require certification by a veterinarian before the mare is bred. It is understood that the stallion owner may have their own veterinarian check the mare for normal breeding condition. Mare owner will be consulted before veterinary treatment is given if it should be necessary.
- b) Mare must be current on vaccinations and **MUST have a copy of current Coggins if bred at Twin Creek Farms.**

3. Release/Hold Harmless: Mare Owner agrees to hold harmless and release Stallion Owner, Breeding Facility, and their respective agents, employees, representatives, assigns, affiliated persons, and/or others acting on their behalf, from liability for ordinary negligence relating to any and all injuries, damages, personal property damages or losses that Mare Owner may sustain arising out of being on the premises of Twin Creek Farms (unless Stallion Owner or Twin Creek Farms intentionally cause the injury, damage or loss or act in reckless disregard for the safety of the Mare.) Mare owner also holds harmless and releases the same aforementioned of ordinary negligence relating to any and all injuries, damages, personal property damages or losses that Mare Owner may sustain arising out of the breeding, handling or keeping of the Mare at Twin Creek Farms that may accrue from any cause whatsoever (including fire, theft, running away, accidents, illness, injuries or death), during the term of this Agreement and/or while the Mare (and foal, if any) is/are in the Breeding Facility's custody and control.

- 4. Live Foal Guarantee:
 - a) Stallion owner agrees to guarantee a live foal (that stands and nurses without assistance after foaling). This guarantee applies only if stallion owner is notified, in writing, within one week following death of foal by a licensed veterinarian. The stallion owner agrees to rebreed the mare during the breeding season in which the foal was lost.
 - b) If mare fails to settle, mare owner has the privilege to return her for breeding during the current breeding season. Mare owner will be required to pay normal collection fee, shipping fee and/or mare care. Mare may be substituted if agreed to by both parties. Breeding must also take place in the same year as contracted unless agreed to by both parties. Mare owner agrees to hold Stallion Owner and breeding Facility harmless if Mare does not settle.
- 5. Breeding Certificate: Breeding Certificate shall be issued at time of foaling.
